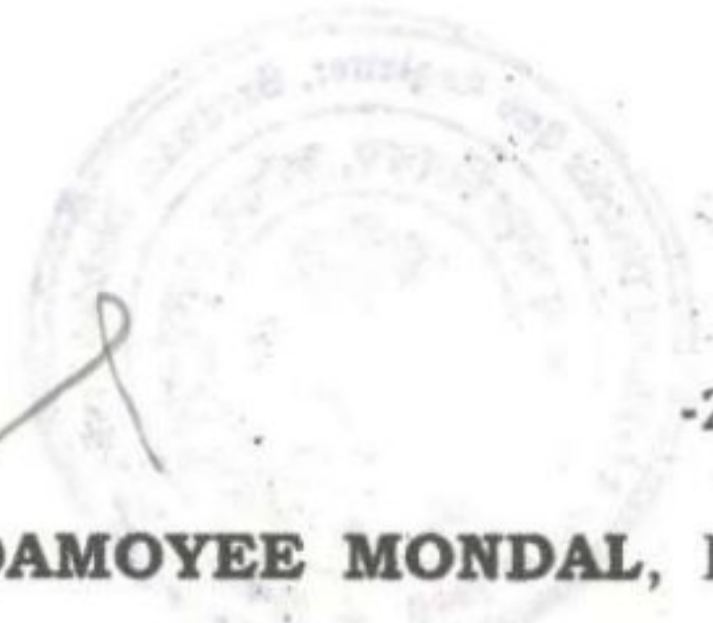

**WHEREAS** the TRUSTEES have agreed to become TRUSTEES and to hold and apply the sum of Rs. 10,000/- (Rupees Ten Thousand) and all gifts, contribution and donations to the said fund including all additions and accretions hereto referred to as the "TRUST"

**WHEREAS** the Settlor and Co-Trustees, having deep interest in the promotion of education, mass awareness, social upliftment, and charitable activities, have decided to form a non-profit and charitable Trust for the welfare of society at large.

**WHEREAS** the Settlor has signified her desire to create a Trust to be known as "BARDHAMAN MASS EDUCATION SERVICE TRUST", hereinafter referred to as the "Trust", to carry out the charitable objects hereinafter set forth.

**WHEREAS** the Settlor has also expressed her intention that the management and administration of the said Trust shall be vested in the Board of Trustees constituted as per this Deed.

**NOW THIS DEED WITNESSETH AS FOLLOWS:**

**1. NAME OF THE TRUST :-**

The Trust hereby constituted shall be known as "BARDHAMAN MASS EDUCATION SERVICE TRUST."

**2. REGISTERED OFFICE :-**

The Registered Office of the Trust shall be situated at Jagat Berh, near or opposite Vivekananda Mahavidyalaya, beside Sriguru Dham, P.O. - Sripally, Dist. - Purba Bardhaman, West Bengal - 713102, and the Working Office shall be situated at Netajinagar, Jhurjhuripole Pouro Hospital Road, P.O. - Nutunganj, District - Purba Bardhaman, West Bengal - 713102, or at such other places as may be decided by the Board of Trustees from time to time.

### 3. AIMS AND OBJECTS :-

The aims and objects of the Trust are purely charitable and educational in nature, including but not limited to:

- A) To impart education through the establishment of schools, academic institutions, and coaching centres.
- B) To establish private academic schools and Schools of Professional Studies.
- C) To promote literacy, mass education, and self-reliance among all sections of society.
- D) To provide financial aid, scholarships, and support to poor and meritorious students.
- E) To advance knowledge in agriculture, animal husbandry, environment, and renewable energy.
- F) To establish and maintain training centres, libraries, research institutions, and vocational courses.
- G) To promote foreign language education and digital literacy.
- H) To organize awareness campaigns against social evils and superstitions.
- I) To establish clean water projects, ambulance services, and community welfare initiatives.
- J) To promote employment awareness and self-employment opportunities.
- K) To undertake all lawful charitable and developmental activities for the benefit of the public without distinction of caste, creed, or religion.
- L) Promote health scheme and health training with medicine awareness or true pise medicine shop.

M) Agricultural innovation to use modern technology, seed providing and give resque to farmers selling corps.

N) Making instalation of Solar Energy Renewable Power.

#### **4. CONTROL AND MANAGEMENT :-**

The management and administration of the Trust shall vest in the Board of Trustees, constituted as per this Deed.

**5. BOARD OF TRUSTEES AND OFFICE BEARERS :-** The Board shall consist of the following Nine (9) Founding Members who shall hold office for life unless removed under the provisions herein:

#### **6. SUCCESSION, REMOVAL, AND VACANCY :-**

A Trustee's position shall fall vacant upon death, resignation, incapacity, or conviction for an offence involving moral turpitude. Any vacancy shall be filled by a resolution passed by a two-thirds majority of the remaining Trustees.

**7. TERM OF OFFICE :-**

All Trustees shall hold office for life unless removed under the provisions of this Deed. New Trustees may be appointed as per Clause 7.

**8. POWERS OF TRUSTEES :-**

The Trustees shall have full authority to:

- a) Manage, invest, and utilize Trust funds and properties.
- b) Acquire, hold, sell, or lease movable and immovable properties.
- c) Employ staff, open branches, and frame by-laws.
- d) Receive donations, grants, and subscriptions.
- e) Perform all lawful acts necessary for the fulfillment of the objects of the Trust.

**9. FUNCTIONS OF THE OFFICE BEARERS :-**

The respective office bearers shall perform the following functions:

- a) President - Head of the Trust, presides over meetings, and supervises overall functioning.
- b) Secretary - Manages daily administration and correspondence.
- c) Treasurer - Maintains accounts, receipts, and disbursements of funds.
- d) Assistant Secretary/Assistant Treasurer - Assist their respective superiors..
- e) General Members - Participate in meetings and decision-making of the Trust.

**10. MEETINGS AND RESOLUTIONS :-**

Meetings of the Board shall be held at least once every three months.

- Quorum: Two-thirds of the Trustees.
